

- 1. What does CORA stand for and what is its mission?
- A: Campaign for Organic and Regenerative Agriculture. It hopes to achieve a pesticide free Pajaro Valley.
- 2. Who did CORA appeal to to stop spraying near schools in the Pajaro Valley?

 A: Driscoll's CEO Miles Reiter (via email)
- 3. What are some ways that pesticides are detrimental to a person's health, according to the article?

A: Asthma, cancer such as brain cancer and leukemia, ADHD or attention deficit hyperactivity disorders, learning disabilities, birth defects

4. What do agriculture industry advocates say in response to complaints about pesticide spraying?

A: That pesticides are heavily regulated and have strict limits on when they can be sprayed near schools. Farms must give advance notice - posted and inform a single administrator at each school (usually principal) directly.

5. According to the regulations passed in 2018 by the state, within what distance do farmers need to inform schools of their pesticide usage?

A: A quarter mile

6: Why do the activists want pesticide spraying near schools stopped?

A: They want the Pajaro Valley to be a beacon for organic agriculture that provides good jobs and protects the health of the students, community members and the environment.

A: California Department of Pesticide Regulation, Santa Cruz County Agricultural Commissioner (Juan Hidalgo), California for Pesticide Reform, EPA, U.S. Department of Agriculture
